Candidates have been surveyed and rated by Illinois Right To Life Action (IRLA) with respect to pro-life issues (abortion, assisted suicide, embryonic stem cell research and related issues). 3 = Will not support most Pro-life issues

2 = Not in full support of all Pro-Life issues

4 = Totally opposed to Pro-Life issues

U = Unknown (Did not complete a survey, or a current survey, or we do not have enough information to enable IRLA to rate properly.)

X = Does not have a Pro-Life position, but we do not have enough information to enable IRLA to give a number rating.
