

Illinois Right To Life Action March 19, 2024, Illinois Primary Election Information

Candidates have been surveyed and rated by Illinois Right To Life Action (IRLA) with respect to pro-life issues (abortion, assisted suicide, embryonic stem cell research and related issues). This was done through websites, surveys, public statements, and/or previous and current voting records. The ratings are to the left of the listing and represent the following:

1 = Fully Pro-Life

2 = Not in full support of all Pro-Life issues

* = An asterisk indicates incumbent.

3 = Will not support most Pro-life issues

4 = Totally opposed to Pro-Life issues

= Rape and Incest Exception

W = Withdrawn or Removed (still on the ballot)

U = Unknown (Did not complete a survey, or a current survey, or we do not have enough information to enable IRLA to rate properly.) X = Does not have a Pro-Life position, but we do not have enough information to enable IRLA to give a number rating.
